

MUNICH, SEPT 6 (CMD)-YESTERDAY'S PLENUM OF THE SLOVAK COMMUNIST PARTY CENTRAL COMMITTEE APPROVED A STATEMENT ON THE FEDERALIZATION OF THE CSSR, WHICH SAID THAT THE FEDERALIZATION OPENED WIDE POSSIBILITIES FOR THE CZECH AND SLOVAK NATIONS FOR THEIR SELF-REALIZATION.

THE STATEMENT AS BROADCAST BY RADIO BRATISLAVA LAST NIGHT SAID THAT "THE PLENUM OF THE CENTRAL COMMITTEE OF THE SLOVAK COMMUNIST PARTY DISCUSSED DURING ITS MEETING ON SEPTEMBER 5, 1968, THE DRAFT OF THE PRINCIPLES OF THE DEFERATIVE CONSTITUTIONAL ARRANGEMENT OF THE CSSR.

"THE FEDERALIVE CONSTITUTIONAL ARRANGEMENT OF THE RELATIONS OF TWO FRATERNAL NATIONS OF THE CZECHS AND THE SLOVAKS IS A HIGHER SYNTHESIS OF THEIR COMMON LIFE FULLY CORRESPONDING TO THOSE MOST PROGRESSIVE, HUMANISTIC TRADITIONS DEVELOPED DURING LONG DECADES BY THE BEST REPRESENTATIVES OF BOTH NATIONS.

"ALSO TODAY, IN THE FATEFUL MOMENTS, THE IDEA OF A JOINT STATE ESTABLISHED ON THE PRINCIPLES OF EQUALITY HAS CONTRIBUTED TO THE UNPRECEDENTED UNITY OF CZECHS AND SLOVAKS, AND ALL NATIONALITIES LIVING ON THE TERRITORY OF OUR REPUBLIC.

"THE LEGALIZATION OF THE CZECHOSLOVAK FEDERATION OPENS TO BOTH NATIONS WIDE POSSIBILITIES FOR THEIR SELF-REALIZATION, FOR THE DEEPENING OF MUTUAL RELATIONS STRENGTHENING THE HEALTHY BASIS OF OUR REPUBLIC.

"THE CENTRAL COMMITTEE OF THE SLOVAK COMMUNIST PARTY NOTES THAT THE BASIC MATERIALS CONCERNING THE FEDERATION WORKED OUT IN THE PERIOD FROM MAY TO AUGUST OF THIS YEAR, AND DISCUSSED BY THE HIGHEST PARTY AND STATE ORGANS ANSWER THE FORMATION OF THE NEW ECONOMIC, RATIONAL, AND NATIONALLY-JUST RELATIONS AMONG OUR NATIONS."

THE STATEMENT SAID FURTHER THAT "THE DRAFT REPRESENTS THE QUALIFIED FOUNDATION FOR FURTHER WORK CONCERNING THE PROJECT OF THE CZECHOSLOVAK FEDERATION SO THAT THE CONSTITUTIONAL LAW ON THE FEDERALIVE CONSTITUTIONAL ARRANGEMENT COULD BE PASSED ON OCTOBER 28 THIS YEAR ON THE OCCASION OF THE 50TH ANNIVERSARY OF THE CZECHOSLOVAK STATE.

IT IS NECESSARY TO DO EVERYTHING SO THAT THE GOVERNMENT COMMISSION FOR THE PREPARATION OF THE CONSTITUTIONAL LAW CAN BE PRESENTED AT THE LATEST BY THE END OF SEPTEMBER ITS ARTICLED WORDING, THAT THE CZECH AND SLOVAK NATIONAL COUNCILS COULD MAKE AN ALL-ROUND ASSESSMENT OF THE DRAFT, AND THAT THE NATIONAL ASSEMBLY OF THE CZECHOSLOVAK REPUBLIC COULD PASS THE LAW IN THE REQUIRED DEADLINE.

"AT THE SAME TIME WE PROPOSE THAT THE PREPARED LAW ON THE NATIONALITIES LIVING IN OUR COUNTRY BE PASSED ON THE 50TH ANNIVERSARY OF THE CREATION OF CZECHOSLOVAKIA.

"IN VIEW OF THE FACT THAT THE PLENUM OF THE CENTRAL COMMITTEE OF THE CZECHOSLOVAK COMMUNIST PARTY OF AUGUST 31, THIS YEAR, HAS DECIDED TO CONVENE THE 14TH EXTRAORDINARY CONGRESS COMMITTEE OF THE CZECHOSLOVAK COMMUNIST PARTY AT A LATER DATE, THE CENTRAL COMMITTEE OF THE SLOVAK COMMUNIST PARTY CONSIDERS IT NECESSARY TO DISCUSS THE DRAFT OF THE PRINCIPLES OF THE CZECHOSLOVAK FEDERATION AT THE NEAREST MEETING OF THE CENTRAL COMMITTEE OF THE CZECHOSLOVAK COMMUNIST PARTY.

"WITH ALL THE CHALLENGING TASKS IN THE COMPLICATED CONDITIONS OF OUR REPUBLIC, IT IS DESIRABLE THAT THE CONSTITUTIONAL LAW ON THE CZECHOSLOVAK FEDERATION BECOME EFFECTIVE ON JANUARY 1, 1969."
